André Lucas is full professor in Finance and vice dean of research at the School of Business and Economics of the Vrije Universiteit Amsterdam. His research of well over 150 papers has spanned many areas of finance, econometrics, and statistics, recently publishing extensively on model instability and time-variation of model parameters, particularly when applied to financial modelling and risk. He has been a director of graduate studies for finance at Tinbergen Institute, program director of Risk Management at Duisenberg school of finance, and program director of the MSc Finance program at Vrije Universiteit Amsterdam.

Authors should submit an extended abstract of up to 500 words. Please include with the submission JEL classification codes for the paper, keywords as well as JEL classification codes. Complete papers may be submitted but the extended abstract is required. In case of more than one author the name of presenter should be underlined.

Submission deadline: **26 April 2018**.

Notification of acceptance: Authors will be notified by the workshop scientific committee's decision by **3 May 2018**.

Authors coming from countries with special visa requirements should specify so in their submission so that they can be notified as soon as possible.
