Stephen G. Cecchetti is a Professor of International Economics at the Brandeis International Business School. He served as head of the monetary and economic department at the Bank for International Settlements in Basel, Switzerland, executive vice president and director of research at the Federal Reserve Bank of New York and editor of the Journal of Money, Credit, and Banking. In 2016, he received an Honorary Doctorate in Economics from the University of Basel.

Steve's research interests include monetary policy, the economics of financial regulation, macroeconomic theory, and price and inflation measurement. He has published widely in academic and policy journals, and is the author of a leading money and banking textbook.

We welcome submissions in all areas of macroeconomics, monetary economics and finance, including monetary and fiscal policies, business cycles analysis, general equilibrium, growth theory, financial analysis, financial and macroprudential regulation, asset prices, corporate finance and asset management. Quality papers in all areas in relation to the overarching theme of the conference are welcome. The main objective of this meeting is to stimulate cooperation of researchers from all over the world. Young economists are encouraged to apply.

WWMF2018 is the first meeting organized by newly established RCEA-Poland. RCEA is an is a private, non-profit international organization dedicated to independent research in applied and theoretical economics and related fields. Originally established in Rimini, Italy in 2007, it is headquartered in Canada and has a branch in Italy and now in Poland.

Submissions

The conference language is English. Authors should submit an extended abstract of up to 300 words. There are no submission fees. Submissions should describe: (1) objectives, (2) methodology and (3) results of the research. Submissions should be made through the conference website: http://rcea-poland.wne.uw.edu.pl/. **Proposals for sessions, consisting of three or four papers, are particularly welcome**. Organized sessions will receive priority in the allotment of time slots.

Submission deadline: 1st April, 2018

Notification of acceptance: Authors will be notified of the conference scientific committee's decision by 9th April, 2018.

Authors coming from countries with special visa requirements should specify so in their submission so that they can be notified as soon as possible.
