André Lucas is full professor in Finance and vice dean of research at the School of Business and Economics of the Vrije Universiteit Amsterdam. His research of well over 150 papers has spanned many areas of finance, econometrics, and statistics, recently publishing extensively on model instability and time-variation of model parameters, particularly when applied to financial modelling and risk. He has been a director of graduate studies for finance at Tinbergen Institute, program director of Risk Management at Duisenberg school of finance, and program director of the MSc Finance program at Vrije Universiteit Amsterdam.
